**ORDER NO. 47**

Dated Guwahati, the 3<sup>rd</sup> July, 2020

Hon'ble the Chief Justice has been pleased to direct that all persons on medical protocol duty, while visiting the houses of Hon'ble Judges in regard to Lordships'/Lordships' family members' ailment; or the hospital shall wear disposable gloves, face masks and face shield.

The disposable gloves be worn while entering the hospital/or the house of the Hon'ble Judges, and be discarded on exiting that place. This safety equipment will be supplied from the High Court Registry.

This order will come in to force with immediate effect.
