With due reference to the above subject and Zoom video conference of MFP Pricing Cell held on 15th April, 2020, I have the honour to submit proposal for revised rates for existing MFPs and inclusion of new MFPs for MSP in Assam.

We propose revised rates for **10 (ten) existing MFPs** and inclusion of **26 (twenty-six) new MFPs** along with minimum support price as given below:
